

Ashland Emergency Fund Walk-A-Thon

The AEF annual walkathon is a fun and fit activity for the entire family. It is a walk on one of three courses through town. The courses start and end at the Stone Park Pavilion; bagels, juice & coffee are served to walkers as they complete the course. Last year we raised \$4,000.00. Our goal this year is \$10,000. The AEF is a local charity helping Ashland folks in need. **100%** of the funds raised are for helping others.

Step One

Get a group together, or your family, or just yourself and complete the attached registration form. Mail or take it to Ashland Emergency Fund, in care of The Homes Connection, 91 Main St., Ashland, MA 01721 along with the registration fee. Make checks payable to **“Walk-a-thon for AEF”**.

Step Two

Start collecting contributions. Use the attached form to keep track of your contributions. The contributions will be collected when you check-in prior to the walk. Tee shirts can be picked up at the check-in at Stone Park on Oct. 2. Tee Shirts are available for only walkers who have pre-registered by September 20.

Step Three

Check- in will start at 8:00 a.m. at the pavilion at Stone Park. You may start walking immediately thereafter. Please bring your money and contribution sheet to the check-in. Tee Shirts will also be given out at this time. You will receive a map and water bottles. **Complimentary bagels, juice & coffee will be served at the finish.** Any outstanding pledges collected after the walk can be turned in at The Homes Connection, 91 Main St.

Remember.....

No running or jogging will be allowed. Walkers are encouraged to wear hats and sunscreen if it's sunny or bring rain gear if it's rainy.

This event doesn't have a rain date. We reserve the right to cancel in extreme circumstances. In that event, there will be no refunds; rather, your registration fee will be accepted as a donation to the Ashland Emergency Fund.
